1	Dr. Madhumita Bandopadhyay	<ul style="list-style-type: none"> ● Limit certain changes to avoid the vastness of the module. ● Add broader conceptual topics in the syllabus at Post-Graduate level. Eg. Keep topics like theories of Imperialism, Theories of History etc. ● In SYBA Semester III Paper III – divide module 1 simply as Early and later Vedic Age; etc.
2	Dr. Sapna Samel	<ul style="list-style-type: none"> ● While making changes, keep the topics connected to each other.
3	Dr. Pradeep Waghmare	<ul style="list-style-type: none"> ● Sir pointed out and suggested the apt change in title of changed modules as well as the specific topics to be included in respective papers.
